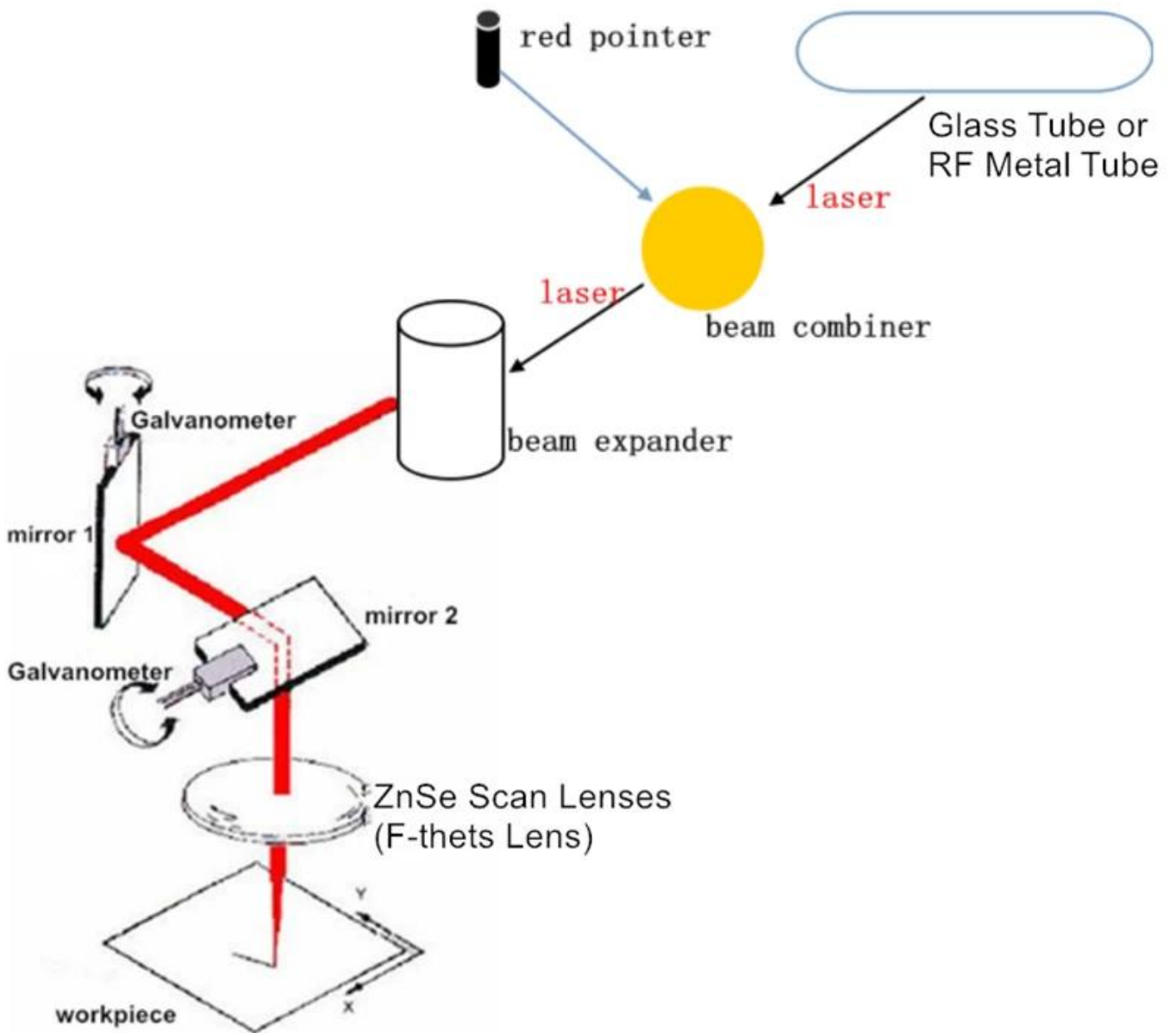

3. For moderately polluted (saliva, oil) in moderate-intensity cleaning.

Infiltrating distilled white vinegar with a cotton swab, wipe the surface a little pressure.
